



BASKETBALL PRE-SEASON MEETING 2017-2018

Meeting took place on Wednesday, October 18, 2017, 4:00 p.m., at the CIF- San Diego Office located at 3636 Camino Del Rio North, Suite #200, Basketball Advisory Group.

Conference representatives not in attendance: Southern conference (boys and girls reps.), Metro conference (boys rep.), and the Grossmont conference (girls rep.)

Please note: the Grossmont conference (girls rep.) noted above called in sick prior to the above meeting.

- CIFSDS office reviewed that updated schedules and scores must be entered on CIF Home by January 5, 2018 or teams will be fined \$100 and will lose the ability to host a playoff game this year. Completed season scores must also be entered February 16, 2018 at midnight, prior to seeding.
- Schedules entered into campus will sync with max preps. However, schedules entered into max preps will not sync automatically with campus. See your Athletic Director for assistance with this sync. Scores may be posted using either format.
- We will be using Max preps for our seeding this year. Advisory advised to remind coaches to check the accuracy of their schedules on max preps for double entries and the wrong teams listed as opponents.

- Finals sites will be adjusted this year. Jenny Craig is not available for our finals this year. Finals will be held at Viejas Arena, Division 5 at La Costa Canyon High School and San Marcos High School for various divisions.
- Basketball Officials reviewed points of emphasis. New NFHS rules handout given to advisory members. Include was the coaches box change for this year. Officials asked that coaches do not enter scrimmages or tournament games into arbiter.
- Reminder to coaches that schedules and scores need to be posted in Max Preps and also in home as a backup to Max preps, new this year.
- Sit-Out Period athletes may not participate in scrimmages.
- Change in the selection of the All CIFSDS teams was announced. Advisory members will be on the committee for selection along with media and a representative of the section office. That meeting will take place immediately following the post-season meeting.
- Information distributed about by law 1206, the number of allowable contacts. Beginning in 2018-19 school year the maximum number of contacts is 28. Each contest counts as a contact for 2018-19. The 20 points allowed for the section is no longer in effect.
- This will change the number of maximum games allowed by tournaments for the 2018-19 season. Those changes will be reflected in the 2018-19 Green Book.
- CIFSDS Courtesy cards will no longer allow you admission into the CIFSDS finals. Teams and their administration will be given badges or ID's to gain entry.
