Executive Committee and Finance Committee member, Deputy Superintendent, Ms. Suzanne O'Connell reviewed and summarized additional audit information with the committee (unfunded liability is now funded regarding employee benefits, sponsor contracts, endorsements, and income). - Mr. Schniepp updated the committee with the Yuma Union High School Ditsrict's interest in becoming a CIF member district. Currently the Y.U.H.S.D. have five (5) high schools that are interested in becoming member schools. Mr. Schniepp has been in communication with the Associate Superintendent, Ms. Lisa Anderson of the Y.U.H.S.D. in regards to the communication and the application process of the district application of their five high schools. Mr. Schniepp and the committee discussed the variables and the possibility of the current section schools travel, league placement, etc. Mr. Schniepp shared that the CIF San Joaquin and CIF Southern Section both have schools from Nevada in their sections.
- Mr. Schniepp discussed with the committee the less than optimal attendance at the last Board of Managers meeting of October 5. A discussion took place regarding a board members role and responsibilities regarding the governance and voting structure of the section. Board Chairperson, Superintendent, Dr. Duane Coleman will communicate with the Board reminding them of the importance and role to the section regarding future attendance at Board meetings.

CIF State Emergency Action Plan, Commissioner, Jerry Schniepp Mr. Schniepp reminded the committee of the mandatory CIF State Emergency Action Plan in which CIFSDS members schools must have a safety plan in place for after school events and activities in order to host a CIFSDS championship. The section has received safety plans from some of the member schools.			
18.	Fall CIF Championships, Assistant Commissioner, John Labeta Mr. Schniepp believed the fall championships went very well and are great events. Mr. Schniepp reported that the power rankings have worked very well for the section in most sports. The section is open to reviewing and exploring new options that the different sport advisories may propose in regards to ranking their sport/teams in the future.			
19.	CIFSDS Master Calendar 2018-2019, CIF Assistant Commissioner, John Labeta Mr. Schniepp informed the committee of the 2018-2019 CIFSDS Master Calendar. The big changes in the calendar are that all state playoff sports will begin one week earlier than in previous years. This change will be significant especially in the sport of football; the section will be reviewing the different/possible options (fewer practices, eliminating the bye, reduction of bracket size, and possibly reducing the amount of teams in the Open division). Mr. Schniepp believes that school's schedules and their championships will be most affected by the change.			

Mr. Schniepp informed the committee that the section experienced some issues in the sport of football regarding power

rankings. Mr. Schniepp shared that some coaches did not like the way the rankings unfolded- nothing is perfect and the section is open to having football use MaxPreps versus the CIFSDS power rankings for football. Per the members of the CIFSDS football advisory and the section Commissioners who met with the football advisory on December 7, 2016, the CIFSDS will use MaxPreps in the sport of football for ranking the 2017-2018 season. Currently the CIFSDS uses LaxPower in the sport of boys and girls lacrosse versus the section's current power rankings structure. Overall Commissioner Schniepp believes the power rankings work very well.
